BOWLER CODE OF CONDUCT AGREEMENT

- 1. As a member of Club Pine Rivers, I acknowledge I am an ambassador of the Club and the sport of bowls and will at all times conduct myself in an exemplary manner whilst representing the Club.
- 2. I will always respect the time and effort put in by my fellow players and/or Club officials, and will ensure my personal preparation for representative play will allow me to perform at my best at all times. I will ensure that my Club uniform is worn with pride, and is always clean and well presented.
- 3. I will observe and abide by the published 'Laws of the sport of bowls', and "Conditions of Play" as may be determined and published by the Controlling Body of the event, and will always abide by any lawful direction or request made by the Controlling Body, Side/Team Manager, Club Selector.
- 4. I will not use loud and/or offensive language or display aggressive or offensive behavior whilst representing the Club, and undertake to encourage my team mates and will respect the opposition's players and/or their play.
- 5. I will observe and abide by Bowls Australia, Bowls Queensland, Moreton Bay District Bowls Association and the Club's Rules and/or Regulations in regard to the service and consumption of alcohol, and/or the licensing requirements of the host club. I will conduct myself at all times in a fit and proper manner whilst on the host club's premises.
- 6. I accept responsibility for keeping my personal level of alcohol consumption to a minimum acceptable level to ensure my playing performance and/or personal conduct is not compromised.
- 7. I will advise the team manager, coach or appointed official of any valid reason for my inability to be present at the appointed time for any Club trial or event prior to their commencement, and undertake to fully support any other person selected or appointed as a replacement player.
- 8. When travelling by Club or privately organised transport, I will conduct myself in an exemplary manner that brings repute to the Club's uniform and the sport of bowls.
- 9. When staying in Club or privately arranged accommodation, I will always conduct myself in an exemplary manner so as not to bring the Club or the sport of bowls into disrepute. I will treat the accommodation's property with care and respect, and acknowledge that, should any breach be proven, I may be liable to pay for any damage arising there-from.
